

**Public announcement**

Provision of a coordination assignment for creating an IT platform to collect, share, and analyze clinical-scientific data produced by Italian Network of Scientific Institutes for patient care and research (IRCCS), called as “*Data Engineer.*”

**In view of the fact that:**

- a) Alliance Against Cancer (hereafter, «ACC») is the principal Italian research association on Cancer. It was founded by the Italian Health Ministry and is currently constituted by 26 Scientific Institutes for patient care and research (IRCCS), AIMaC, Italian Saroma Group, CNAO Foundation, and Italian National Institute of Health, where ACC offices are located.
- b) Among the ACC objectives, the principal is to promote networking and research activities across IRCCS and other cancer research centers to implement cancer diagnosis and therapies
- c) For the purposes mentioned above, on 19 November 2019, ACC as Actuator Subject, and in conjunction with the Cardiological Network and the Neuroscience and Rehabilitation Network, has entered the agreement n. 2019/CCR-2018-23669122 with the Italian Ministry of Health. The agreement concerns the entrustment of the research project “Virtual pathology institutes of the IRCSS Italian Networks: prevent disease, personalize cure and improve patients’ quality of life.” The project, endowed with the endowment 2018-2028 provided for by the Italian Authorization Bill n. 25 2016. This project aims to create a technological platform for the collection, sharing, and analyses of clinical and scientific data obtained from patients of each participating IRCCS of three networks (*Health Big-Data Project*).
- d) To support this project's activities, ACC needs to hire a highly qualified external professional figure with expertise in coordinating the collaborative project to create the IT platform. The IT platform has the principal role of collecting, analyzing, and sharing clinical-scientific data originated by the engaged IRCCS. The selective procedure will be open "in such a way as to ensure adequate publicity for the selection notice, broader access to candidates, transparency, and strictness of procedure." (art. 5 project's convention "*Health Big Data*")

## **(A) SECTION 1 – REQUESTING PARTY**

- Denomination: Alliance Against Cancer (ACC) - an association supervised by the Italian Ministry of Health, which brings together public and private IRCCS carrying out translational cancer research in Italy.

## **(B) SECTION 2 – OBJECT**

- *Denomination:* Public notice for the assignment of engagement for the coordination of activities dedicated to processing computer infrastructure related to the project *Health Big Data* indicated in the foreword "*Project Manager Data Scientist*."
- *Brief description:* The line of action is aimed at search and selection of exclusively one professional figure to be included in the *Health Big Data* project, as indicated in the foreword. The new member of the staff will provide technical and coordination support for the strengthening of the IT platforms of the participating IRCCSs. Furthermore, she/he will also be engaged in creating a centralized IT platform to achieve the extraction, interoperability, integration, and storage of clinical and scientific data (*Data Engineer*).
- *Nature and duration of the relationship to be established:* Coordinated and collaborative collaboration contract. The term of the assignment is fixed in 3 years and is renewable.
- *Compensation:* The annual gross compensation will be correspondent to the competence and experience of the candidate. It will range between euro 50,0000.00 (fifty thousand) and euro 66,000.00 (sixty-six thousand) per year gross, payable in 12 months.
- *Location of examination:* to be defined within one of the IRCCS participating in the Research Project

## **(C) SECTION 3 – ADMISSION REQUIREMENTS**

1. The following requirements are demanded

1) **REQUIREMENT N. 1** – degree:

- Master's degree from one of the following classes, according to D.M. 270/2004:

- LM – 40 (Mathematic)
- LM – 17 (Physics);
- LM – 32 (Computer engineer)
- LM – 18 (Computer Science or Bioinformatics)

and the corresponding equivalences for bachelor's degrees (old system) and advance degrees, or equivalent qualification obtained abroad.

2) **REQUIREMENT N. 2** - Excellent command of the English language. For non-Italian citizens, a good knowledge of Italian language is required.

3) **REQUIREMENT N. 3** - Full enjoyment of civil and political rights

4) **REQUIREMENT N. 4** – Not having been dismissed, dispensed, or declared deprived of employment in a Public Administration or banned from public offices.

5) **REQUIREMENT N. 5** - Not having reported convictions, even not definitive, for one of the crimes covered by Book II, Title II of the Penal Code (Crimes against the Public Administration), with the exception of decriminalization, extinction, and rehabilitation.

6) **REQUIREMENT N. 6** – Not to be older than the age laid down by the laws in force for retirement.

7) **REQUIREMENT N. 7** – Italian citizen:

- citizens of a foreign State are put on an equal footing with an Italian citizen

2. The candidates must meet all requirements for admission on the due date of the deadline for submission of application form

#### **(D) SECTION 4 – DEADLINES AND CONDITIONS FOR SUBMITTING APPLICATIONS**

1. The application form for selection participation must be submitted on ordinary paper with the kinds of transmission and at the contact details as referred to in point 2 below, and must contain:

a) declaration in lieu, in Italian or English, made by the candidate pursuant to and for the purposes of Articles 46 and 47 of the d.p.r. 445/00 based on the outline referred to in Annex "A," in which the candidate attests that she/he meets the admission requirements related to Section 3 of this notice, also including:

- a detailed CV in European format, in Italian or English, dated and signed, attesting to training and professional activities.

- a copy of a valid identity document;

- a motivation letter written in Italian or English;

- Three reference letters written in Italian or English;

- Any documents or statements which may be useful for the assessments referred to in Sez. 5, point 4;

b) Your consent to the processing of personal data provided, made in accordance with the scheme referred to in Annex "B," pursuant to and for the purposes of Articles. 12, 13 and 14 of EU Regulation 679/2016, drawn up in Italian or English.

2. The applications to the public selection must be received within 60 days after the notice publication or no later than 24:00 on the day **26/10/2020** with the following formality:

3. ACC does not assume any responsibility for failure to receive the application within the prescribed period, evidenced by the stamp and date of the accepting post office. Further, ACC does not assume any responsibility for mistakes caused by postal offices or delivery agencies attributable to third parties, unforeseeable circumstances, or reasons beyond control.

5. Before signing the employment contract, ACC will verify the fulfillment of the candidate's admission requirements first in the ranking through official verifications and appropriate documentary requests to the candidate. In the event of a negative result of these assessments, the candidate will be excluded; consequently, the next candidate in the ranking shall be considered.

## **(E) SECTION 5 – SELECTION PROCESS**

1. The identification of the contract's addressee will follow a comparative evaluation of the candidates based on assessment of professional titles and oral interview by a selected Examining Board.

2. The Examining Board will be appointed by the ACC General-Director by adopting an appropriate provision that will be published on the ACC website.

3. The Examining Board will first examine the applications received, verify eligibility requirements, and assess the candidates' qualifications. The Examining Board will only allow candidates who meet the admission requirements (see section 3) to undergo the subsequent evaluation of titles. The list of eligible candidates will be published on the ACC website under the Notices and Notices section.

4. The Examining Board will then assess the qualifications in the light of proven professional, cultural and scientific specialization:

- from university and postgraduate training

- from proven experience:

1. Modeling and development experience in data management and distributed architectures and the ability to use frameworks such as HDFS, Kafka, Cassandra, Kubernetes
2. Experience in the development of applications for the management and scalability of Big data projects
3. Software development experience in collaborative environments (Jira, Confluence, GIT)
4. Experience with continuous integration, uni-testing, integration testing, infrastructure as code.
5. Experience in writing and maintaining documentation for data management and software developers.
6. Experience in working teams in a geographically distributed and multidisciplinary team.
7. Experience in team management and basic experience in project management
8. Keen interest in the application of big data solutions to the health sector
9. Experience in Institutions and/or Companies of at least four years

5. The Examining Board will admit to the oral interview only candidates with qualifications deemed suitable for the exam of the tasks covered by this selection, as specified in Section 2, and that in the comparative evaluation of the same titles reach at least 30 points (in a score from 0 to 40). The list of candidates admitted to the oral interviews will be published on the ACC website at the Notices and Notices Section.

6. The Oral interview through teleconference is aimed at deepening the training and professional experience gained by the candidate. In particular, to evaluate personal motivation as well as assess specific technical, relational, and communicative skills, the excellent knowledge of the English language or a good understanding of the Italian language for non-Italian citizens, the skills and the competence to perform the functions required by this selection.

7. The date, place, and time of the interview will be published on the ACC website ([www.alleanzacontroilcancro.it](http://www.alleanzacontroilcancro.it)) at the Announcements Section at least 7 (seven) days before starting the test and at the same time communicated to the admitted candidates by email.

8. The modalities of the interview will found the “*Guidelines for conducting staff selection tests through the video interview.*” Failure to be present at the interview, for any reason, will be deemed a waiver of the selection.

9. At the end of the selection, the Examining Board will approve and publish on the ACC website the ranking list of candidates admitted, having assessed the curriculum vitae of each eligible candidate and the results of the individual interview, assigning to each candidate the following scores, based on total score up to a maximum of 100 points:

assessment criteria-score (MAX)

- a) training and professional experiences: 40 points

b) outcome of the interview: 60 points

Total score: 100 points

10. The Board's assessments will be carried out solely for the technical-discretionary purposes of identifying the most suitable candidate for the collaboration contract covered by this notice, in the exercise of ACC's private autonomy under the Civil Code. The same assessments will not bind ACC to the recruitment of the first candidate first in the ranking list. Participation in the procedure will not entitle for hiring, not even to the first candidate graduated.

11. If necessary, the Board will ask the candidates additional supplement information and clarifications on the documentation submitted.

12. ACC reserves the right to carry out appropriate checks of the declarations contained in the application for participation in the selection of Annex A according to art. 71 of the Presidential Decree No. 445/2000

13. ACC reserves the right to cancel and/or revoke the present procedure at any time, without the circumstance giving any title to the candidates or the first candidate in the ranking for compensation, indemnities or other compensations.

#### **(F) SECTION 6 – RECRUITMENT AND CONCLUSION OF THE CONTRACT**

1. The candidate first in the list ranking will stipulate a continuous and coordinated collaboration contract, in compliance with the provisions of the Italian Civil Code and Legislative Decree no. 81/2015 and other applicable forecasts due to the nature of the assignment conferred.

2. The working relationship will be carried out personally by the selected subject, in full autonomy, and without constraints of subordination.

3. The collaboration contract will automatically be terminated if there is a conflict of interest towards ACC. In the event of conflicts of interest before selection or situations of incompatibility, the contract will not be concluded.

#### **(G) SECTION 7 – COMMUNICATION TO APPLICANTS**

All communications following the deadline for the presentation of the self-candidacy will be published on the website, in the Notices Section. All communications will have the value of notification for all legal purposes.

#### **(H) SECTION 8 – PROCESSING OF PERSONAL DATA**

The personal data, obligatorily provided, will be processed in compliance with Legislative Decree no. of 10 August 2018, n. 101, which adapts the Code on the protection of personal data (Legislative Decree no. 30 June 2003, n. 196) to the provisions of the Regulation (EU) 2016/679, and only for the requirements related to this procedure and for those resulting from

the possible establishment of the employment relationship, as also provided in the information notice under Annex "B."

**(I) SECTION 9 – APPLICABLE LEGISLATION**

1. This notice is related to a selective private procedure carried out by ACC within the private autonomy framework referred to in the Civil Code.
2. For anything not expressly provided in this notice, reference is made to the provisions of the Civil Code on Employment Relations and the other provisions applicable.

**(L) SECTION 10 – EQUAL OPPORTUNITY**

This notice is issued respecting equal opportunities between men and women to access employment and financial treatment, according to Legislative Decree no. 198/2006.
